

# **OFFICIALS' FEES & POLICIES**

### **Collegiate Rated Official:**

\*2-person crew: \$175 \*3-preson crew: \$160

**USAL Level One(L1) – Level Three(L3)** 

\*2-person crew: \$145 \*3-preson crew: \$130

\*\* It is strongly recommended that the WCLA prioritize the use of CWLOA-rated officials for all games, taking into consideration budgetary constraints. While the WCLA is not currently mandated to exclusively use CWLOA-rated officials, doing so would enhance the quality and consistency of officiating in WCLA games. By utilizing CWLOA-rated officials, the WCLA can ensure that games are officiated by highly trained and knowledgeable individuals who are wellversed in the rules and regulations of women's collegiate lacrosse. This would ultimately benefit the players, coaches, and spectators by promoting fair and accurate officiating throughout the league.\*\*

**Standard Game:** This fee structure is defined for a "standard" Four 15-minute guarter, stop after goals (SAG), stop the last two minutes of each guarter.

**<u>Playday and Tournament Play:</u>** For sites that have three games or more, teams can negotiate with the local umpire boards for a lower tournament fee.

Fall and Spring Play: Pay for Fall and pre-season scrimmages shall be 80% of the standard rates if a running clock is used. If a standard game is played standard rates will apply and this must be clarified with the assignor. Travel to be determined by assignor/region.

#### **Ground/Travel Time Fee:**

This fee is compensation for travel time and is based on roundtrip door-to-door miles. The driver and all passengers are paid this fee. The travel time fee is set annually using the IRS mileage rate announced in January and is: (Total roundtrip miles - 30 miles) x IRS mileage rate.

Note: for 2024 this rate is \$0.65.5









#### Per Diem:

The fee is \$50.00 per day while on travel; provided one or more of the following situations:

- the official's roundtrip mileage is 300 miles or more
- an official must travel by air to a game site
- the game(s) necessitates officials staying overnight

#### **Accommodations:**

Reasonable actual lodging/hotel and local parking fees should be covered when the event necessitates an official to stay overnight. Arrangements/fees should be agreed by the assigner/teams prior to the event.

#### Air Travel:

The actual cost of airfare and associated fees (parking, mileage to airport, etc.) shall be covered. Arrangements/fees should be agreed by the assigner/teams prior to the event. Per diem fees will apply for the door-to-door travel time involved.

## **Cancellation Policy:**

In the event a game or playday is cancelled, or partially cancelled the host manager/assigner should notify the officials directly as soon as possible. If the games are cancelled, or the event has been modified and the officials have already departed to the event the following fees shall apply.

For Single, Local Games Situations:

<sup>\*\*</sup> In situation #6, it is recommended that umpires be compensated for a minimum of half the originally scheduled games. For instance, if there were two games initially scheduled, the official should be paid for one game. Similarly, if there were three games originally scheduled, the official should be paid for two games. This approach ensures that officials receive fair payment for their services, considering the number of games they were initially contracted for. \*\*
